## B. Liquor Store report

1. Skip Carpenter with the Small Business Development Center presented a financial analysis pertaining to the Liquor Store. He reported Ms. Aasland has done a good job with the Liquor Store. Mr. Hanson asked if there was an advantage to eliminating the on sale and open the off sale only. He indicated that this question is constantly asked and nobody has an answer. The Council thanked Mr. Carpenter for his report.

## C. Public Safety report

1. The discussion was the cost to provide Fire Department support for the races at Norman County Fairgrounds. Previous racing organizers were paying \$225 per race for two or three firemen and one truck. There is no current contract with the Jake Bitker. Mr. Bitker explained the races last about three hours and felt that \$50 an hour, the same they are paying the ambulance personnel for a one day total of \$150.
